STATEMENT

TAP ANNOUNCES THE PRICING OF €375 MILLION 5.625% SENIOR NOTES DUE 2024

PORTUGAL — November 22, 2019.

Transportes Aéreos Portugueses, S.A. ("TAP") today announced that it has completed the successful pricing of €375.0 million in aggregate principal amount of 5.625% senior notes due 2024 (the "Notes"). The Notes will be issued at an issue price of 99.463%.

The offering is expected to close on December 2, 2019. The Notes are expected to be admitted to the Official List of Euronext Dublin and admitted to trading on its Global Exchange Market. The proceeds from the offering will be used (i) to prepay certain borrowings under TAP's existing debt and extend its average maturity, (ii) to pay fees and expenses related to the offering of Notes and (iii) for general corporate purposes.

The Notes will be offered only to qualified institutional buyers pursuant to Rule 144A and outside the United States pursuant to Regulation S under the U.S. Securities Act of 1933, as amended (the "Securities Act"), subject to prevailing market and other conditions.
